Telecom Development Corporation Afghanistan ("Roshan") – Taxes and Fees  
Outstanding to 31<sup>st</sup> December 2019

Our various meetings with your Excellency and honourable staff of the Ministry of Finance refer. Thank you for setting up the meetings accordingly and extending your support to Roshan.

As formally requested by the working team please see below the ask we have of the Government on the principal amount of taxes and fees due to 31<sup>st</sup> December 2019. The total taxes and fees due as of 31<sup>st</sup> December 2019 are as follows:

Roshan would like to request the government to spread this outstanding principal amount over 5 years payable in equal semi-annual installments commencing June 30, 2020. The installment amount would be ~AFN 233.6m. Last payment would be made December 2024.

Note this will not impact the annual recurring taxes and fees that Roshan pay the Government which are in the range of AFN 2.5 Bn to AFN 3Bn a year. If we look at the total taxes and fees paid by Roshan in the last three years to Nov 2019, it comes up to nearly AFN 7.5bn.

The above relief from the Government, coupled with relief we are asking of our other stakeholders and shareholders will allow us to continue to invest in broadband to offer the Afghan population internet and connectivity in all provinces across the Country. This will only further aide economic growth and development of the Country. As you know, AFKED is very committed to the long-term development in Afghanistan and is investing in new projects including power in Badakshon and also looking to invest in agriculture projects to help drive future economic growth.

I look forward to hearing back and potentially meeting with you before the year is closed
